## Installation - MacOS

To install Instability as an Audio Unit (AU):

Copy *Instability.component* to */Library/Audio/Plug-Ins/Components/*

To install Instability as a VST3:

Copy *Instability.vst3* to */Library/Audio/Plug-Ins/VST3/*

If you use a custom folder for your plug-ins copy *Instability.component* and/or *Instability.vst3* to that folder.

## Installation - Windows

To install Instability as a VST3:

Copy *Instability.vst3* to *C:\Program Files\Common Files\VST3*

If you like to use a custom folder for your plug-ins copy *Instability.vst3* to that folder.

## Uninstalling

Go to the folder to which you copied *Instability.component* and/or *Instability.vst3* and delete the file.
